Contributions are not tax deductible. Marshall Tuck for State Superintendent of Public Instruction 2018 may accept contributions of up to \$7,300 for the primary election and \$7,300 for the general election. Spouses and domestic partners may each contribute the maximum, even if the same person controls their account, as long as they both sign the check, credit card authorization form or accompanying letter. *Small contributor committees may contribute up to \$14,600 per election.*

We may not deposit your check or credit card payment without your name, street address, occupation and employer, and may not accept cash, cashier's checks or money orders. A business and its owner, partnerships with the same general partner, and other affiliated entities are subject to a single, combined limit of \$7,300 per election. We may not accept contributions that have been reimbursed by another person unless you inform us of the true source of the contribution; we may also not accept contributions from foreign nationals, or state lobbyists registered to lobby the State Superintendent of Public Instruction or the State Department of Education. Investment firms doing business with CalSTRS or the UC Retirement Plan, as well as their employees and partners, may trigger certain SEC "pay-to-play" restrictions by contributing to this committee, and are encouraged to consult with legal counsel before contributing. All contributors must be 18 years of age or older. The campaign has chosen to accept contributions only from individuals— contributions from corporations or PACs will be returned.
